- 3. Mr. Baldwin provided a brief overview of his organization and stated he would be providing an assessment for the Authority's review.
- 4. Chairman, Bob Zschoche, informed members of the public the recommendations will be heard in a public forum before any action is taken.

- o Vice Chairman, Barry Lerman, stated he would like to have further discussion on the \$20K contribution before approving it in the FY 2017/2018 Budget.

K. Unfinished Business

- 1. Considered proposed FY 2017/2018 Budget.
 - Chairman, Bob Zschoche, suggested the Budget approval be postponed due to significant changes expected to the FY 2017/2018 budget due to the impending divesting of the Flight Center to Total Flight Solutions (TFS). Chairman, Zschoche stated a preliminary budget was presented to the Moore County Board of Commissioners.
 - Chief Flight Instructor, Jack Stevens, provided an update to the Authority on the progress of the transition. Mr. Stevens informed the Authority all Airport Flight Instructors had been offered positions with Total Flight Solutions and will begin scheduling with TFS by May 1, 2017.
 - Airport Manager, Greg Hudson, stated refunds would be given to current Flight Center Customers with account credits and the sale of the Aircraft to TFS is still moving forward.
 - o Vice Chairman, Barry Lerman, notified the public of the agreement to re-assume the Flight Center should TFS cease operations.

L. New Business

- Discussed reconciling the Airport Project Requests on file at the County with the NCDOT TIP.
 - The Authority directed Airport Manager, Greg Hudson, to schedule a TBI assessment of the Airport's NCDOT TIP projects. The Authority requested the TIP also include a Master Plan Update.
 - o Chairman, Bob Zschoche, stated an updated TIP will be provided to the County reflecting the revised planned projects.
- 2. Considered revising the Airport's Minimum Standards insurance requirement of \$2 Million.

 Upon motion made by Secretary, Mike Jones, and seconded by Vice Chairman, Barry Lerman, the Authority voted 4 to 0 to approve reducing the Airport's Minimum Standard Insurance requirement of \$2 Million to \$1 Million.
