I. Presentations/Guest Speakers

- 1. Sandhills Community College Aviation Program Coordinator, Keith Davies, provided the Authority with an update on the Aviation Program and indicated the College was deeply invested. Mr. Davies stated he was seeing a lot of interest and growth in enrollments. The Authority, Total Flight Solutions Flight School, and Mr. Davies expressed their willingness to work as partners to benefit students by streamlining the training and by informing the Community of the Program and all it has to offer.
 - Public member, Ted Owens, inquired about any foundations that are in place as a funding source for scholarships to support the Aviation Program. Mr. Davies indicated the Sandhills Foundation is in place for anyone wanting to contribute/donate to the Aviation Program.
- 2. Ken Haenlien, former Time Saver Aviation owner, expressed his desire to build a new Hangar, with on-going discussions occurring with McMurray Fabrics to potentially coown the facility.
 - By consensus, the Authority indicated they are open to the request and would consult with the Airport Engineers, Talbert & Bright, Inc., regarding the requested Hangar Development.
 - Mr. Haenlien stated the proposed timeline to break ground is as early as October 2019. Mr. Haenlien also stated he hoped to have more details available at the next Airport Authority Meeting in September.

1. Minimum Standards Status Report.
