J. Presentations/Guest Speakers

- 1. Amy McLane, Talbert & Bright, Inc., presented the next phase of the Master Plan Grant Project.
 - Ms. McLane provided the Master Plan Alternative Analysis to the Authority, outlining the details of each Alternative.
 - Alternative 1: "Status Quo" maintain current length/DD's, improve

ROFA

- Alternative 1A: "Improve Operating Lengths" Alt. 1 + extend ROFA/RSA to 1,000' at each runway end
- Alternative 2: "Existing Runway Unconstrained" Remove displaced thresholds and DD's, provide 1,000' ROFA/RSA beyond each runway end
- Alternative 3A: "Extend Runway to 7,120", Runway 5 End" unconstrained condition
- Alternative 3B: "Extend Runway to 7,120', Runway 23 End" unconstrained condition
- TBI requested input on which alternative(s) to move forward with. The
 Authority requested alternative 3A and 3B defined in the presentation be
 included in the scope. Ms. McLane explained a stakeholders meeting will be
 scheduled and the finalized Alternative Analysis is expected to be presented to
 the Authority in November.
- o Ms. McLane advised the Authority of the new FAA concept "Hot Spots": taxiways should not be designed to lead directly from an apron to a runway without requiring a turn." By consensus, the Authority agreed with the removal of taxiway B2 to be in compliance with the FAA concept.
- Ms. McLane informed the Authority a draft of their approved Master Plan Facilities Requirements was sent to the NCDOA. The NCDOA concurred with the findings in July 2019.
