# New Business

## 1. AVA Technologies Global- Hangar Development Proposal

Ava Tech is a defense-focused software and engineering firm specializing in autonomous systems, data analytics, and systems integration. As a provider of advanced technologies to the defense and intelligence sectors, their operations often involve secure, high-tech equipment and unmanned systems such as drones or autonomous aircraft.

Benjamin and his team presented plans for a 100'x100' or 120'x100' hangar with a 3,500-5,000 sqft office space.

Estimated at \$2.6 Million investment; seeing 20–30-year land lease.

Moore County Airport prefers to build and lease hangars rather than allow companies to build their own due to reversion clause issues.

#### K. Projects, Summaries and Updates

#### 1. Infrastructure Projects

Apron reconstruction project scope expanded due to poor condition assessment. Taxiway upgrades design in progress, with completion expected by end of summer. Land release request submitted for property across the street. RPZ project to demolish old buildings moving forward.

#### 2. Financial and other key performance indicators

April revenue: \$495,102; Expenses \$334,255; Net Income: \$160,846. YTD net income of \$177,823 (Excluding \$1M hangar purchase adjustment) Positive cash flow, but long-term sustainability concerns due to high capital costs.

## 3. Commercial Air Service

In discussions with airlines about potential service (daily to DC airport).

Airline is requesting ~1.5 million per year minimum revenue guarantee over 2 years.

Airport plans to reapply for SCASD grant to help fund guarantee.

Will be meeting with local leaders to discuss support and funding.

# 4. Staffing Updates

Hired 1 Full time and 2-part time Service Line Technicians. Advertising for new FBO manager position. Plan for interviews in the next coming weeks.
