### H. New Business

- 1. DOT Visit in February The DOT is visiting Sanford in early February. Mr. Stilwell will provide additional information as it becomes available.
- Annual Strategic Meeting in February Airport Director Maness requested
  the Authority to set the date and time for the Annual Strategic Meeting in
  February. The purpose of this meeting is to develop goals for the coming
  year. Chairman Jones and Airport Director Maness will develop an agenda
  for the day. The Authority agreed to hold this meeting during the Authority
  meeting on February 8, 2023. This will be an all-day event.

#### I. Old Business

 Marketing/Website/Community Outreach Presentation and Update-Tarheel Communications and Convergent Systems LLC – Mr. Peter Stilwell introduced Mr. Chris Smith, of Convergent Systems, LLC. Mr. Smith reviewed the changes to the Airport's website, and upcoming changes. Mr. Smith also introduced Moore County Airport's presence on LinkedIn. The fee will be \$1,000/month for social media including website updates.

The Authority approved the plans for the website and LinkedIn; and agreed to keep working with Convergent Systems LLC, by consensus.

- J.T. Stilwell provided updates on upcoming events, including but not limited to: American Red Cross Blood Drive February 14; Motor & Moore Car Show February 18; EAA Young Eagles Day and Moore County Airport Community Open House April 15; Sandhills Motoring Festival May 27
- Steve Bright of Talbert & Bright introduced a land optimization plan. The
  Authority requested another view of what the Authority could do with the
  land Northwest of the hangars; and with land that is owned already. Airport
  Director Maness will work with Talbert & Bright.

There was a discussion about the terminal renovations. The consensus was to bring the project in-house to complete. Airport Director Maness will locate an architect and construction company to complete the agreed upon work.

- 3. Enterprise Rental Car Discussion Airport Director Manes is continuing to discuss compensation for the work Airport Staff does on behalf of Enterprise. Details will be available soon.
- 4. ADK Chairman Jones presented the tentative plan to screen applicants for the Airport Director position. There may be some candidate interviews in February or March, 2023.

# J. Projects Reports, Summaries and Updates

- 1. Business Advisory Committee Report None.
- Activities New and Noteworthy Airport Director Maness notified the Authority that the Runway Rehabilitation project will begin on Monday, January 16. An engineer will be onsite for the duration of the project. Communications with Base Customers will be ongoing as the project ramps up.

On Thursday, January 19, the Runway and Taxiway Lighting project will start ramping up too. Supplies for the project will be staged at the Airport.

Airport Director Maness requested approval for the Talbert & Bright Work Authorization to proceed with the Solicitation, Design-Build RFQ.

M/S – McPherson/Horne – That the Moore County Airport Authority approve the Work Authorization from Talbert & Bright to continue with the Solicitation, Design-Build RFQ for a new corporate hangar at F16.

Both Fred Smith and Daniels and Daniels requested extensions through February due to supply chain issues, and weather. Both were approved by consensus.

The Airport is waiting for CAD files and reappraisals for the land swap.

The Authority requested Airport Staff to start assigning hangars.

The Authority also requested Mr. John May to proceed with the offer for the storage property.

There has been no update from Gattis about the Storage Building.

Airport Director Maness gave an update on the issue with ultralights at the Airport. He spoke with the FAA about the safety issues associated with having ultralight at the Airport. The FAA will investigate the issue.

Airport Director Maness met with Slim Thompson about an apprenticeship program at Sandhills Community College. Plans are being coordinated with Sandhills Community College and Sovereign Aerospace to establish a program.

Related to the program, Airport Director Maness re-introduced an incentive for students. One option is for students at the College to receive a discount on the first 10 hours of flight school. Airport Director Manes will work on a plan and present it to the Authority at the next meeting.

Airport Director Maness reported that with the new Titan agreement, the Airport will receive three brand new fuel trucks. The Airport will also switch from Total FBO to Atlas.
