I. Old Business

- Estimates for Terminal Renovations: Airport Director Maness provided a summary of the two quotes received from Ascot and Southern Builders. He has requested a depiction of changes. He will bring a recommendation to the Authority in April, for a vote.
- 2. Long-Term Goals: Chairman Jones opened the discussion about the Airport's goals. The Authority will discuss this further.
- 3. Live Feed of Runway Activities: Airport Director Maness addressed concerns about a live feed to the Airport's website. A consensus was reached that if fresh content is added to the website weekly, a live feed of runway activities wouldn't be needed. Airport Director Maness committed to updating the website with fresh content on a weekly basis.

- 1. Airport Director Maness provided an update on the following projects:
 - Next week, there will be a walk-through of the punch list for the new hangars;
 - The Corporate Hangar RFQ has been released and responses are due March 31; A SOQ meeting will take place on Tuesday, March 21, at 1:00 p.m. at the Airport;
 - The Runway markings will be completed next week;

- Amanda Connor, Manager of Aviation Business for the North Carolina Department of Transportation, Division of Aviation, visited the Airport;
- On Tuesday, March 21, at 10:30 a.m. a pre-construction meeting for the Lighting Project will be held. The Lighting Project will result in nighttime runway closures;
- Airport Director Maness will follow-up and provide an update on the Maintenance Building;
- On Monday, March 27, at 10:30 a.m., the Authority will hold a Special Closed Session meeting to discuss the Airport Director recruitment;
- On April 4, the Authority will meet with the Moore County Board of Commissioners in a Special meeting – a PowerPoint presentation will be available. Mr. Haenlein has offered to stage planes in front of the terminal for this meeting.
